□ Copies of Bank Statements (Optional)

These statements are not required but can help us best understand how you use your current bank, find ways to save you money, or even earn you money with our rates and discounts.

□ Your Smart Phone, if you have one (Optional)

This is not required, but we can help you set up your Mobile Banking App if you bring in any activated smart phone.
