Volkwein spent three years at Barclays Capital as managing director and global head of private placements and 12 years at Merrill Lynch & Co. He earned a B.A. in economics from Harvard University and an MBA from New York University, Leonard N. Stern School of Business.

Chamberlain is head of corporate sales and responsible for leading the Bank’s foreign exchange and fixed income teams in the U.S. He has nearly 20 years of experience working with corporate derivatives. Chamberlain, who worked at Goldman Sachs for 12 years, was a managing director in the Corporate Risk Management group and led their interest rate derivative coverage effort. Before Goldman Sachs, he spent eight years at JPMorgan Chase where he started his career as an analyst and worked his way up to associate then vice president in corporate derivatives. Chamberlain has a B.A. in economics from Colgate University.
